Attendance stas for FY23 Q1 show a decrease in number of activities – this is planned reduction to meet interprofessional requirements under the ACCME accreditation. In addition, the Online Program is working on course bundling by specialty or areas of interest to better promote our courses.

The noted difference between attendance vs. credits awarded is attributed to the credits mixed offered with in-person symposium credits (higher credits/activity).

Also, the decrease with psychology participation is attributed to FY23 not being a relicensure year (FY22 was relicensure year). Same case with some of the employee and others participation. Human Trafficking, which was still required in FY21 and FY22, but not in FY23.


VI. OLD BUSINESS
